The participants are passionate about bettering their communities, but may not always understand the role of political leadership in that process. IGNITE teaches young women how to think critically about policy and understand where the levers of power to make change actually reside. Via IGNITE's high school curriculum, college chapters, annual conferences, and elected women network, IGNITE teaches young women to become civically engaged and ultimately step into public service. In 2022-23, IGNITE trained 6,000+ young women across the country through a combination of in-person and virtual programming.
